

The Oregon Racing Commission is proud to support racing at the Oregon State Fair Meets with the following programs.

\$35,000 ORC 2018 SUMMER FAIR MEET JOCKEY INCENTIVE PROGRAM

To encourage jockey participation at summer fair meets the Oregon Racing Commission is again offering bonus money for all jockeys who ride at the summer meets, with a minimum of \$35,000 to be distributed. Highlights of the program include: A guaranteed losing jock mount of \$60.00 which includes a \$15.00 contribution from the ORC jockey incentive fund; a daily cash award of \$50.00 to participants available to ride each race day; and an additional "all-meets" bonus to those who participate at each of the five fair meets. Additional incentives to be announced by individual fairs. The program is jointly administered by the ORC Stewards and the Fair Meet Directors of Racing.

ORC EIA (Coggins) Policy ALL horses entering into the grounds of a fair meet race track in Oregon are required to have a valid negative Coggins within 6 months of entering the fairgrounds. For horses racing at the meet, the racing secretary shall be in charge of compliance and shall verify and photocopy the ORIGINAL color owner NCR Coggins and record the data with InCompass when possible. Horses not racing but on the grounds will be required to produce the same documentation as horses racing at the meet. Stewards, Investigators, Association representatives, and the State Veterinarian will walk shed rows and review and collect the papers to ensure compliance with the policy. Please review the entire Coggins policy statement if you have any questions. It is available at the ORC website and the OHBPA website. Direct mailings have also been sent out to licensees affected by the policy.

The Oregon Horsemen's Benevolent Protective Association is excited to announce the following programs in support of 2018 summer fair race meets!

Added Purse Money. The OHBPA is again adding over \$70,000 to purses this year for the summer race meets. This contribution will result in an average \$500 increase in all thoroughbred races and mixed breed races with at least one thoroughbred starter.

OHBPA Sponsored Race. The OHBPA will continue our long history of sponsoring the OHBPA Purse race at each race meet with an added \$1,000. The winning owner will also receive an OHBPA halter and braided lead rope.

Trainer of the Day Program. The OHBPA is sponsoring for the third year the very popular Trainer of the Day program. Each day a Thoroughbred trainer will be randomly selected at the draw and receive \$100 from the OHBPA as our Trainer of the Day. A trainer may only win once during the summer. While it is not a large amount of money, it is a sincere gesture from the OHBPA Board showing our appreciation and a big Thank You for supporting racing at our summer fairs.

Dental and Vision Benefits. If owners and trainers start Thoroughbred horses at the summer fairs, those starts will count toward dental and vision benefits from the OHBPA. To qualify for benefits, you must have three starts in the year. Please see the OHBPA website for further details.

Guaranteed Money per start. New this year every thoroughbred horse that is an official starter in a race is guaranteed a minimum purse of \$100. This will help all owners and trainers with the cost of jockey mounts and pony persons.



The Oregon Thoroughbred Owners and Breeders Association is happy to offer the following programs to promote the owning, racing, and breeding of Oregon-bred Thoroughbreds.

OTOBA SUMMER FAIR PROGRAM

Oregon Bred Thoroughbred Owner's Bonus

The OTOBA will pay a bonus to the owners of Oregon-bred Thoroughbreds based on their earnings from Thoroughbred races at the five summer meets. The total bonus pool available is \$12,750. The bonus will be distributed proportionally to owners. If an Oregon-bred stakes race is not run, the \$500 purse supplement will be added to the bonus pool. The bonus amount will be determined at the end of the summer meets and is dependent on the total earnings from all Oregon-bred Thoroughbreds competing. No set percentage or amount is guaranteed.

Breeder's Awards for Oregon Bred Thoroughbreds

10% of 1st – 5th Place earnings on Thoroughbred races at the Oregon Summer Meets will be paid to the Breeder.

Stakes Races

OTOBA will add \$500.00 to the purse for one Oregon-bred Stakes race one Oregon-bred Filly/Mare Stakes race at each Oregon Summer Meet.

Please note: The OTOBA Hi Point Challenge and Race Series are discontinued.

Summer Stakes Races

This summer the Oregon Quarter Horse Racing Association (OQHRA) is sponsoring major races at Grants Pass Downs (SOHRA) Race Meet and the Prineville (Crooked River Round Up) race meet. OQHRA will be adding \$4,000.00 to the Grants Pass Derby in July, \$15,000.00 to the Firecracker Futurity on July 4th and \$1,500.00 to the Prineville Futurity in July. The winner of both the Firecracker Futurity and the Prineville Futurity will receive a Montana Silversmiths Trophy Buckle to wear or put in their Trophy Case.

With the \$4,000 added by OQHRA The Grants Pass Derby is estimated to have a purse of \$10,800.00. The Firecracker Futurity, the summer's premier Quarter Horse race, is estimated to have a purse of \$30,000.00 and the Prineville Futurity is estimated to have a total purse of \$6,500.00.

Overnight Quarter Horse Races

In addition, OQHRA will be adding \$500.00 to the purse of all overnight Quarter Horse races at each summer Fair Race Meet.

Oregon Quarter Horse Racing Association will guarantee \$100 to all quarter horses who starts in a race at the summer fair meets. If a horse finishes 6th, 7th or 8th the horse will earn \$100. For example, if a horse earns \$54.00, OQHRA will provide \$46.00 to bring the total earnings to \$100.
