Based on a meeting last Monday in Baltimore, MD, it seems likely that the New AAEP/RMTC approach will be to:

 Eliminate a number of therapeutic medications from the AAEP/RMTC list.
Reduce the amount of experimental data required for a threshold/withdrawal time determination.

Given these forthcoming changes, I think it will be very helpful going forward to have a very established record of the medication rules/thresholds in place or projected in early 2012, just before the proposed changes in change in regulatory direction by RMTC/ARCI.
